REMARKS

EACH of the Level 2 member publications should appear on the coupon. The only exception to this is if your publication does not exchange ads with other papers in your country. There should be no publications listed in ICMA coupons other than those in the Level 2 listing above.

Not all papers that have a website can publish an ICMA ad on the Internet. You may only do so if you have applied for an Electronic membership with ICMA. ONLY the members marked with “*” can publish a ICMA ad on the Internet. Each of these papers must have an identifying mark (e.g. “*) beside their listing on your coupon.

In addition to the web-publishing indicator, you must also publish a web warning to your customers. The web-marks and web-warning are very important as they warn customers of possible local access to phone numbers and addresses if an ad is placed in a publication which publishes ads on the internet.
